

• What gives you the most anxiety about Clery Compliance?



Typical gripes...

- How long is Timely?
- We believe the incident wasn't a legitimate threat-but what would an auditor think?
- Why do we worry about non-campus properties?
- Who reads this, anyway?
- Apples to Apples?
- Our senior leadership doesn't really like to see these stats
- The community demands are more than the Clery obligation calls for

In the timeliest manner...

- How are we defining "Timely" and is it consistent for each incident?
- Timely may depend on resources, availability, initial investigative information, etc....



From a recent program review...

- An institution was fined for not sending a notification for a fondling incident, and a few weeks later another fondling incident occurred which showed a pattern of ongoing threat to the community
- While this is may be accurate from the auditor- is it possible, and do we have the resources in place to send a notice for times like this?
- Where is the line between notifying campus and flooding them with messages that aren't likely to have much influence?

Get away from my property... no seriously just commit a crime over there...

- At a time when many institutions are acquiring more property near their main campus- the footprint can change frequently.
- If a Clery crime occurs one side of a road vs another- is campus safety really impacted?

Nobody ever recommends the ASR as a lovely little read...

- Pages among pages of policy and procedures
- The time involved in putting it together is massive
- Everyone just skips to the stats anyway
- 71... no 46

Crime interpretation isn't always apples to apples...

- Consider incidents such as dating violence and domestic violence
- Think about theft of property vs a burglary definition
- Not all schools think of these the same way- and both can be right



Everyone's going to hate me when I present these numbers...

- We are compliance people- people are going to hate to see us coming
- The numbers are the numbers- we aren't the reason for these police reports, we just tally them
- Always explain that you will give the information to your most senior leadership as the compliance expert- and that can be news they may not be happy to hear.

The community demands more than the Clery obligation...

- This is a growing trend and one that can be difficult to navigate
- Recent examples at Pitt and Clemson
- How do you appease students and staff, but not create unnecessary chaos?



Ideas to improve on...

- What can we do today...
 - Improve documentation
 - Make reporting easier
 - Make documenting decisions easier
 - Additional training methods
 - Directive training for your most vital CSA's
 - Use your other colleagues
 - Make sure your policies are what you are putting into practice
 - Improved transparency
 - Mini-reports
 - Partnerships with local media outlets
 - Work with parents when possible
 - An "Update" blog
